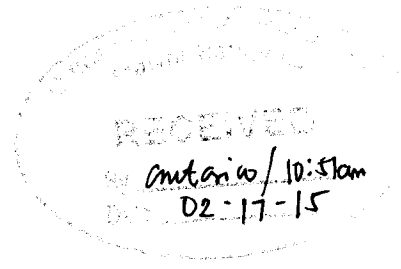

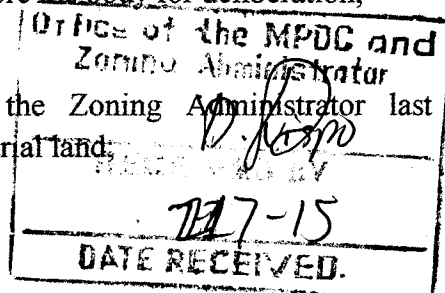
**APPROVAL OF RECLASSIFICATION OF LAND DESCRIBED AS LOT NO. 547
UNDER ASSESSMENT OF PROPERTY NO. 15-0005-01210 AND TCT/OCT NO.
T – 52233 WITH TOTAL AREA OF NINE THOUSAND NINE HUNDRED FORTY ONE
(9,941) SQUARE METERS FROM AGRICULTURAL LAND TO MEMORIAL LAND,


