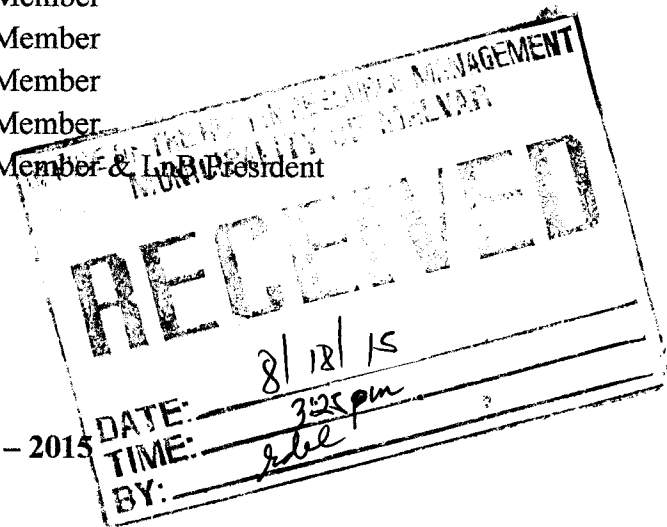

**SECTION 3. EFFECTIVITY.**


This ordinance shall take effect upon its approval.
