**SECTION I INVITATION TO BID**  
**CONSTRUCTION OF TWO (2) STOREY 4CL SCHOOL BUILDING**  
**AT SAN ISIDRO NATIONAL HIGH SCHOOL BARANGAY SAN ISIDRO, MALVAR, BATANGAS**

1. The *Municipality of Malvar*, through the Special Education Fund 2016 intends to apply the sum of Five Million Pesos (P 5, 000, 000.00) Pesos being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Two (2) Storey 4 CL School Building at San Isidro National High School Barangay San Isidro, Malvar, Batangas. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Municipality of Malvar* now invites bids for Construction of Two (2) Storey 4 CL School Building at San Isidro National High School Barangay San Isidro, Malvar, Batangas. Completion of the works is required within 180 calendar days upon the effectivity of the contract or not later than seven (7) days upon receipt of Notice to Proceed. Bidders should have completed, at least 50% of a contract similar to the project from the date of submission and receipt of bids. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five (75%) percent interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from Municipality of Malvar and inspect the Bidding Documents at the address given below during office hours.
5. A complete set of Bidding Documents may be purchased by interested Bidders on February 15, 2016 – March 01, 2016 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Thousand (P5, 000.00) Pesos.
6. The *Municipality of Malvar* will hold a Pre-Bid Conference on *December 22, 2016 at 9:00 A.M* at CCR Function Room Julio M. Leviste Hall San Pioquinto, Malvar, Batangas, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before January 05, 2017 at 9:00 A.M at CCR Function Room Julio M. Leviste Hall San Pioquinto, Malvar, Batangas. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in Instructions to Bidders Clause 18.  
  
Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids will not be accepted.
8. Submission of Letter of Intent for the said project will be on December 14, 2016 – January 04, 2017.
9. The Municipality of Malvar reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
